| January 4 – September 10, 2010 | Nomination Period Starting January 4 th , 2010 nomination forms may be filed with the Clerk during regular business hours (8:30am-4:30pm). On Nomination Day September 10, 2010, nomination forms may be filed between the hours of 9:00 a.m. and 2:00 p.m. |
| September 7, 2010 | Voter's List The voters' list will be available at the Municipal Office, the Parry Sound Public Library, and at the Parry Sound Hydro Office from September 7, 2010 to October 25, 2010. The Municipal Elections Act does not allow the voters list to be posted in a public place. In order to protect personal information, viewing of the Voters' List will be supervised. |
| September 7 – October 25, 2010 | Revisions to Voters List Application to Remove, Add, or Amend an Elector's Name During the period that begins on the Tuesday after Labour Day and ends at the close of voting on voting day, a person may make an application to the Clerk requesting; a) that the person's name be added to or removed from the voters' list; or b) that information on the voters' list relating to the person be amended. 1996, c. 32, Sched., s.24(1) Application for removal of another's name Tuesday, September 7, 2010 to Nomination Day Friday September 10 th , 2010. | <p>September 10, 2010</p> | <p>Nomination Day Filing Nomination Forms Last day for filing nominations. Nomination forms filed on this day may only be filed between the hours of 9:00 a.m. and 2:00 p.m.</p> <p>Withdrawal of Nomination Forms Nominations may be withdrawn by the candidate, or his/her agent, by filing the withdrawal in writing with the Clerk before 2:00 p.m. on Friday, September 10, 2010. If the withdrawal is filed by an agent, it must be accompanied by written authorization provided by the candidate.</p> |
| <p>September 10 – October 25, 2010</p> | <p>Vote by Proxy The Clerk is able to delegate authority for the issuance of proxies. Any person whose name is on the Voters List or who has been added by revision may vote by proxy. The appointment may only be made after the time for the withdrawal of nominations has expired for all offices for which the election is being conducted, which is now 2 p.m. on Nomination Day. (September 10, 2010). (However, the list of candidates is not "final" until after the Clerk certifies the nominations by no later than 4 pm on Monday September 13, 2010). The date appointments may be made is after 2 p.m. on Friday, September 10, 2010, unless additional nominations are required under sec. 33(5). The person appointed must be entitled to be an elector. A person appointed as a proxy may only act for 1 person unless the person is the spouse, sibling, parent, child, grandparent or grandchild of the person making the appointment. The person appointed a voting proxy shall complete an application in the prescribed form including a statutory declaration that the person is the person appointed a voting proxy and shall</p> |

| | bring the form in person to the clerk at the Clerk's office. On the day of an advance poll the Clerk's office will receive applications for voting proxy and will review and certify. No Proxies will be certified after 5:00 p.m. on Voting Day October 25, 2010. |
| September 13, 2010 | Certification of Nomination Prior to 4:00 p.m. on the Monday following Nominations Day, the Clerk shall examine each nomination filed and, if satisfied the person is qualified to be nominated and that the nomination complies with the Act, the Clerk, or designate, shall certify as such on the nomination filed. If not satisfied, the Clerk shall reject the nomination and as soon as possible give notice to the person who sought to be nominated and all other candidates for that office. The Clerk's decision to certify or reject a nomination is final. |
| October 4 – 8, 2010 | Voter Notification Cards mailed out to all electors on the Voter's List. Bring card with you to vote at Advance Polls or on Voting Day! |
| Wednesday October 13, 2010 | Advance Poll – The Friends (27 Forest Street) – 12:00 p.m. to 8:00 p.m. – Bring your voter notification card and identification (proof of name and qualifying address). |
| Saturday October 16th, 2010 | Advance Poll – The Friends (27 Forest Street) – 10:00 a.m. to 6:00 p.m. – Bring your voter notification card and identification (proof of name and qualifying address). |
| Wednesday October 20, 2010 | Advance Poll – The Friends (27 Forest Street) – 12:00 p.m. to 8:00 p.m. – Bring your voter notification card and identification (proof of name and qualifying address). |
| October 25, 2010 | Election Day – Bobby Orr Community Centre Exercise your democratic right to elect your representatives to municipal council and school board council! Be counted in 2010! |

| December 31, 2010 | <p>End of Campaign Period</p> <p>Candidates may not raise funds or incur expenditures beyond December 31st, 2010 unless the candidate is continuing his or her campaign to erase a deficit. If the candidate has a deficit and wishes to extend their campaign period, they must file a Form 6 with the Clerk, or designate, before December 31, 2010 (Section 68(4)).</p> <p>Note: Town of Parry Sound Municipal Office will be closed on Friday December 24th from Noon on until Wednesday December 29, 2010 and again on Friday December 31st will be closed from Noon on until January 4, 2011.</p> |
| March 25, 2011 8:30 a.m. – 2:00 p.m. | <p>Financial Statement Deadline</p> <p>All candidates must file a financial statement by 2:00 p.m. even if the nomination was withdrawn or the campaign period extended.</p> |
